### **PRICE LIST FORMAT**

- A. Page Numbering** - Page numbers appear in the upper right corner of the page. Pages are numbered sequentially. However, new pages are occasionally added to the price list. When a new page is added between pages already in effect, a decimal is added. For example, a new page added between pages 14 and 15 would be 14.1.
- B. Page Revision Numbers** - Revision numbers also appear in the upper right corner of each page. These numbers are used to determine the most current page version on file with the Commission. For example, the 4th revised Page 14 cancels the 3rd revised Page 14. Because of the various suspension periods and deferrals the Commission follows in its price list approval process, the most current page number on file with the Commission is not always the price list page in effect. Consult the check sheet for the page currently in effect.
- C. Paragraph Numbering Sequence** - There are seven levels of paragraph coding. Each level of coding is subservient to its next higher level:

- D. Check Sheet** - When a price list filing is made with the Commission an updated check sheet accompanies the filing. The check sheet lists the pages contained in the price list, with a cross reference to the current revision number. When new pages are added, the check sheet is changed to reflect the revision. All revisions made in a given filing are designated by an asterisk (\*). There shall be no other symbols used on this page if these are the only changes made to it. The price list user should refer to the latest check sheet to find out if a particular page is the most current on file with the Commission.

- (C)** - To signify changed condition or regulation
- (D)** - To signify a discontinued rate, regulation or condition
- (I)** - To signify an increase
- (K)** - To signify that material has been transferred to another sheet or place in the price list

### **APPLICATION OF PRICE LIST**

This price list contains the regulations and rates applicable to the furnishing of intrastate resale common carrier communications service by Clear World Communications Corporation ("Clear World" or "Carrier") between various locations within the State of Washington.

## **DEFINITIONS**

**Access Line** - An arrangement which connects the Customer's telephone to an Clear World designated switching center or point of presence.

**Authorization Code** - A pre-defined series of numbers to be dialed by the Customer or Authorized User upon access to the Carrier's Travel Card Service network to identify the caller and validate the caller's authorization to use the services provided.

**Authorized User** - A person, firm, partnership, corporation or other entity who is authorized by the Customer to be connected to and utilize the Carrier's services under the terms and regulations of this price list.

**Called Party** - The person, individual, corporation, or other entity whose telephone number is called by the End User. For calls placed on an collect-only basis, the Called Party accepts responsibility for payment of the charges for use of Clear World's services.

**Carrier or Company** - Whenever used in this price list, refers to Clear World Communications Corporation, unless otherwise specified or clearly indicated by the context.

**Clear World** - Refers to Clear World Communications Corporation.

**Collect Call** - A billing arrangement by which the charge for a call is billed to the called party, provided the called party accepts the charge with a positive response.

**DEFINITIONS, (CONT'D.)**

**Commission** - The Washington Utilities and Transportation Commission.

**Customer** - A person, firm, partnership, corporation or other entity which arranges for the Carrier to provide, discontinue or rearrange telecommunications services on behalf of itself or others; uses the Carrier's telecommunications services; and is responsible for payment of charges, all under the provisions and terms of this price list.

**Dedicated Access Origination/Termination** - Where access between the customer and the interexchange carrier is provided on dedicated circuits. The cost of these dedicated circuits is billed by the access provider directly to the Customer.

**LATA** - Local access and transport area. A geographic area established by the US District Court for the District of Columbia in Civil Action No. 17-49, within which a local exchange company provides communications services.

**DEFINITIONS, (CONT'D.)**

**Personal Account Code** - A pre-defined series of numbers to be dialed by the Customer or Authorized User which identifies and validates the caller's authorization to use the services.

**Serving Wire Center** - A specified geographic point from which the vertical and horizontal coordinate is used in calculation of airline mileage.

**Switched Access Origination/Termination** - Where access between the customer and the interexchange carrier is provided on local exchange company Feature Group circuits and the connection to the customer is a LEC-provided business or residential access line. The cost of switched Feature Group access is billed to the interexchange carrier.

**V & H Coordinates** - Geographic points which define the originating and terminating points of a call in mathematical terms so that the airline mileage of the call may be determined. Call mileage may be used for the purposed of rating calls.

## **SECTION 1 - REGULATIONS**

### **1.1 GENERAL DESCRIPTION OF SERVICE**

- a.** Carrier is a resale common carrier providing outbound 1+, inbound "800" and travel card services to Customers for their direct transmission and reception of voice, data, and other types of communications.
- b.** Long distance usage charges are based on the actual usage of Clear World's network. Chargeable time for all calls begins when a connection is established between the calling station and the called station. Chargeable time for all calls ends when either party "hangs up" thereby releasing the network connection. There is no billing applied for incomplete calls.

**SECTION 1 - REGULATIONS, (CONT'D.)**

**1.2 LOCATIONS OF SERVICE**

- a.** Communications for all other services may originate in any area within the State of Washington.
- b.** Communications for all services offered by the Carrier may terminate to any area within the State of Washington.

**1.3 LIMITATIONS OF SERVICE**

- a.** Service is offered subject to the availability of the necessary facilities and/or equipment and subject to the provisions of this price list. The Carrier reserves the right not to provide service to or from a location where the necessary facilities or equipment are not available.
- b.** The Carrier reserves the right to discontinue furnishing service pursuant to WAC 480-120-081.
- c.** Title or lease rights in all facilities provided by Carrier under these regulations remains in the Carrier.

**SECTION 1 - REGULATIONS, (CONT'D.)**

**1.4 USE OF SERVICE**

- a.** Service may be used for the transmission of communications by the Customer.
- b.** Service may not be used for any unlawful purpose or for any purpose for which any payment or other compensation is received by the Customer, except when the Customer is a duly authorized and regulated common carrier.

**1.5 INTERCONNECTION**

- a.** Service furnished by the Carrier may be interconnected with services or facilities of other authorized communications common carriers and with private systems, subject to the technical limitations established by the Carrier. Service furnished by the Carrier is not part of a joint undertaking with such carriers. Any special interface equipment or facilities necessary to achieve capability between the facilities of the Carrier and other participating carriers shall be provided at the Customer's expense.
- b.** Interconnection with the facilities or services of other carriers shall be under the applicable terms and conditions of the other carriers' price lists. The Customer is responsible for taking all necessary legal steps for interconnecting Customer-provided terminal equipment or communication systems with Carrier's facilities. The Customer shall secure all licenses, permits, rights-of-way, and other arrangements necessary for such interconnection.

**SECTION 1 - REGULATIONS, (CONT'D.)**

**1.6 PAYMENT AND BILLING**

- a.** Service is provided and billed on monthly (30 day) basis. Service continues to be provided until canceled by the Customer pursuant to WAC 480-120-081.
- b.** The Customer is responsible for payment of all charges for services and equipment furnished to the Customer, End User or to an Authorized User of the Customer by the Company.
- c.** All charges due by the Customer are payable upon receipt to the Company or to any agency authorized to receive such payments.
- d.** Bills are due and payable upon receipt. Unpaid bills become delinquent thirty (30) days after the mail date and subject to a 1.5% late payment penalty.
- e.** A return check charge of \$25.00 will be assessed for all checks or drafts presented for payment which are returned for insufficient funds.

**SECTION 1 - REGULATIONS, (CONT'D.)**

**1.7 MINIMUM SERVICE PERIOD**

The minimum period for service is one month (30 days) unless otherwise specified in this price list.

**1.8 CANCELLATION BY CUSTOMER**

- a.** Where an application for service is canceled by the applicant prior to the start of any special design work or installation, no charge applies.
- b.** Where special design work has been started prior to the cancellation, appropriate connection charges as shown in the Company's price list will apply.
- c.** If cancellation is requested subsequent to the time special design work has been started, the application will be cancelled by the Company and the Company may collect a charge equal to the estimated costs incurred in the special design work, less estimated net salvage.

**SECTION 1 - REGULATIONS, (CONT'D.)**

**1.8 CANCELLATION BY CUSTOMER, (Cont'd.)**

- d.** Special design work is considered to have been started when the Company incurs any expense in connection with, or in preparation for, provision of service which would not otherwise have been incurred, provided:
- the Customer has advised the Company to proceed with installation, and
  - the Company accepted the order.
- e.** If cancellation is requested after completion of any special design work, it will be treated as a discontinuance of service and the minimum requirements of the rate will be applicable.

**1.9 CANCELLATION OR SUSPENSION BY CARRIER**

- a.** The Carrier may discontinue service pursuant to WAC 480-120-081.
- b.** Clear World Communications Corporation may temporarily suspend service without notice to the Customer, by blocking traffic to certain cities or NXX exchanges, or by blocking calls using certain Personal Account Codes when the Company deems it necessary to take such action to prevent unlawful use of its service. Clear World will restore services as soon as service can be provided without undue risk.

**SECTION 1 - REGULATIONS, (CONT'D.)**

**1.10 CREDIT ALLOWANCES FOR INTERRUPTION OF SERVICE**

- a.** Credit allowances for interruptions of service which are not due to the Carrier's testing or adjusting, to the negligence of the Customer, or to the failure of channels, equipment or communications systems provided by the Customer, are subject to the general liability provisions set forth in this price list and limited to the initial minimum billing period call charge for re-establishing the interrupted call.
- b.** It shall be the obligation of the Customer to notify Carrier immediately of any interruption in service for which a credit allowance is desired by Customer. Before giving such notice, Customer shall ascertain that the trouble is not within his or her control, or is not in wiring or equipment, if any, furnished by Customer and connected to Carrier's terminal. Interruptions caused by Customer-provided or Carrier-provided automatic dialing equipment are not deemed an interruption of service as defined herein since the Customer has the option of using the long distance network via local exchange company access.

**1.11 RESTORATION OF SERVICE**

The use and restoration of service in emergencies shall be in accordance with the priority system specified in Part 64, Subpart D of the Rules and Regulations of the Federal Communications Commission.

**SECTION 1 - REGULATIONS, (CONT'D.)**

**1.12 LIABILITY**

- a.** The liability of the Carrier for damages arising out of mistakes, omissions, interruptions, delays, errors or defects in transmission occurring in the course of furnishing service or other facilities and not caused by the negligence of the customer, commences upon activation of service and in no event exceeds an amount equivalent to the proportionate charge to the customer for the period of service during which such mistakes, omissions, interruptions, delays, errors or defects in transmission occur. For the purpose of computing such amount, a month is considered to have 30 days.
- b.** The Carrier is not liable for any act or omission of any other company or companies furnishing a portion of the service other than the Carrier underlying carrier.

**SECTION 1 - REGULATIONS, (CONT'D.)**

**1.12 LIABILITY (Cont'd.)**

- c.** The Carrier shall not be liable for and the Customer indemnifies and holds the Carrier harmless from any and all loss claims, demands, suits, or other action or liability whatsoever, whether suffered, made, instituted or asserted by the Customer or by any other party or persons, for any personal injury to, or death of, any person or persons, and for any loss, damage, defacement or destruction of the premises of the Customer or any other property, whether owned by the Customer or others, caused or claimed to have been caused directly or indirectly by the installation, operation, failure to operate, maintenance, removal, presence, condition, location or use of equipment or wiring provided by the Carrier where such installation, operation, failure to operate, maintenance, condition, location or use is not the direct result of the Carrier's or its underlying carrier's negligence.
- d.** The Company shall not be liable for any claim, loss, or refund as a result of loss or theft of Personal Account Codes issued for use with the Company's services.

**SECTION 1 - REGULATIONS, (CONT'D.)**

**1.13 TAXES AND SIMILAR EXACTIONS**

The Company shall charge the Customer an amount sufficient to recover any governmental assessments, fees, license, or other similar taxes or fees imposed upon the Company. The Company concurs in the Municipal Utility Occupation tax schedules of each Local Exchange Company price list in the state of Washington to the extent those local taxes are both current and applicable to the services the Company provides. Such taxes or fees shall be recovered in the following manner:

For all services offered by the Company, taxes and fees shall be added pro-rata, insofar as practical, to the rates and charges stated in the Company's rate schedules and listed as separate line items on the Customer's bill for services provided.

## **SECTION 2 - RATES AND CHARGES FOR SERVICE**

### **2.1 GENERAL**

Rates may vary by call duration, type of service, and time of day. Nonrecurring, monthly recurring and usage sensitive rates apply as described in this price list. Intrastate service is provided in conjunction with interstate service.

**SECTION 2 - RATES AND CHARGES FOR SERVICE, (CONT'D.)**

**2.2 TIME OF DAY RATE PERIODS**

- 2.2.1** Long distance usage charges are based on the actual usage of the Company's network. Chargeable time for Calling and Travel Card calls begins when the calling and the called station are connected.
- 2.2.2** Chargeable time ends when the calling service point terminates, thereby releasing the network connection. If the called party hangs up but the calling number does not, chargeable time ends when the network connection is released by signal from the called party location or by automatic timing equipment in the telephone network.
- 2.2.3** Unless otherwise specified in this price list, the minimum call duration for billing purposes is eighteen (18) seconds.
- 2.2.4** Unless otherwise specified in this price list, usage is measured and rounded in six (6) second increments for billing purposes.
- 2.2.5** The Company shall not bill for unanswered calls.

**SECTION 2 - RATES AND CHARGES FOR SERVICE, (CONT'D.)**

**2.3 CALCULATION OF DISTANCE**

Usage charges for mileage sensitive products are based on the airline distance between the serving wire center locations associated with the originating and terminating points of the call. The distance is calculated by using the "V" and "H" coordinates of the serving wire centers as defined by BellCore (Bell Communications Research), in the following manner:

**Formula:**

$$\sqrt{\frac{(V_1 - V_2)^2 + (H_1 - H_2)^2}{10}}$$

## **SECTION 2 - RATES AND CHARGES FOR SERVICE, (CONT'D.)**

### **2.4 RATE PERIODS**

Unless otherwise indicated elsewhere in this price list, all usage-based rates are subject to the following time-of-day, day-of-week, and holiday rate periods:

- 2.4.1** Day Rate Period - Applies to that portion of a call occurring from 8:00 AM to, but not including, 5:00 PM Monday through Friday.
- 2.4.2** Evening Rate Period - Applies to that portion of a call occurring from 5:00 PM to, but not including, 11:00 PM Sunday through Friday.
- 2.4.3** Night/Weekend Rate Period - Applies to that portion of a call occurring from 11:00 PM to, but not including 8:00 AM all days, 8:00 AM to, but not including, 11:00 PM Saturday; 8:00 AM to, but not including, 5:00 PM Sunday.
- 2.4.4** When a call is established in one rate period and ends in another rate period, the rate in effect at the calling station applies to the portion of the call occurring within that rate period. When a unit of time is split between two rate periods, the rate applicable to that unit of time is based on the rate period in which it began.

**SECTION 2 - RATES AND CHARGES FOR SERVICE, (CONT'D.)**

**2.5 CLEAR WORLD PLAN A**

**2.5.1 Clear World Plan A 1+ Outbound Service**

Clear World Plan A 1+ Outbound Service is available to small to medium sized business Subscribers who originate direct dialed calls over standard customer-provided switched access lines. Minimum monthly usage is between \$0 and \$49.99 per month. Calls are billed in six (6) second increments after an initial minimum call duration of eighteen (18) seconds. Intrastate service is offered in conjunction with interstate offerings.

**2.5.2 Clear World Plan A - 800 Service**

Clear World Plan A 800 Service is available to small to medium sized business Subscribers for terminating calls to switched access lines provided by the Subscriber. Call charges are billed to the Subscriber and not to the party originating the call. Calls are billed in six (6) second increments after an initial minimum call duration of eighteen (18) seconds. A monthly service fee applies per account. Intrastate service is offered in conjunction with interstate service.

**(A) Rates**

**2.5.3 Clear World Plan A - Travel Service**

Clear World Plan A Travel Service is available to small to medium sized business Subscribers for placing long distance calls over the Company's service while away from home or office. Call Charges are billed to the Subscriber's Travel Card account or to the Subscriber's presubscribed account service. Calls are billed in six (6) second increments after an initial minimum call duration of thirty (30) seconds.

There is a \$0.30 surcharge for all calls made with a calling card from pay phones. There is no surcharge for calls not made from pay phones.

Minimum monthly usage is between \$50.00 and \$99.99 per month. Calls are billed in six (6) second increments after an initial minimum call duration of eighteen (18) seconds. Intrastate service is offered in conjunction with interstate offering.

Call charges are billed to the Subscriber and not to the party originating the call. Calls are billed in six (6) second increments after an initial minimum call duration of eighteen (18) seconds. A monthly service fee applies per account. Intrastate service is offered in conjunction with interstate service.

**2.6.3 Clear World Plan B - Travel Service**

Call charges are billed the to Subscriber's Travel Card account or to the Subscriber's presubscribed account service. Calls are billed in six (6) second increments after an initial minimum call duration of thirty (30) seconds.

There is a \$0.30 surcharge for all calls made with a calling card from pay phones. There is no surcharge for calls not made from pay phones.

Minimum monthly usage is \$100.00 and above per month. Calls are billed in six (6) second increments after an initial minimum call duration of eighteen (18) seconds. Intrastate service is offered in conjunction with interstate offerings.
